Hurtsellers is a board member of Pomona Capital and serves on the ICI's board of governors. She was also a member of the U.S. Treasury Borrowing Advisory Committee from 2013 until 2021. 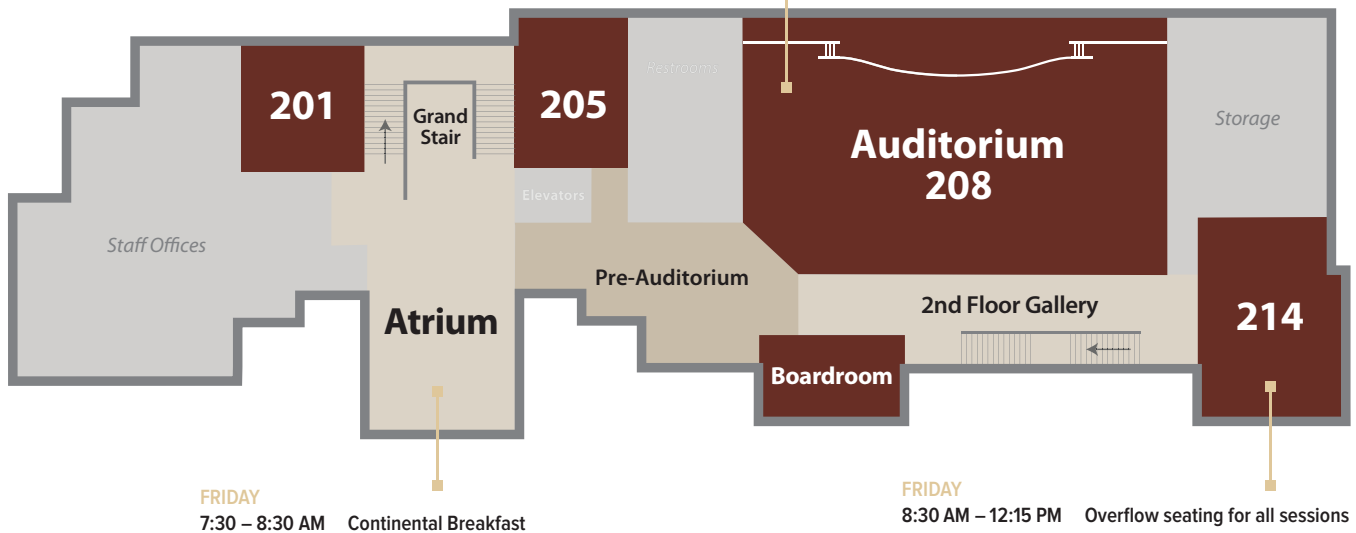

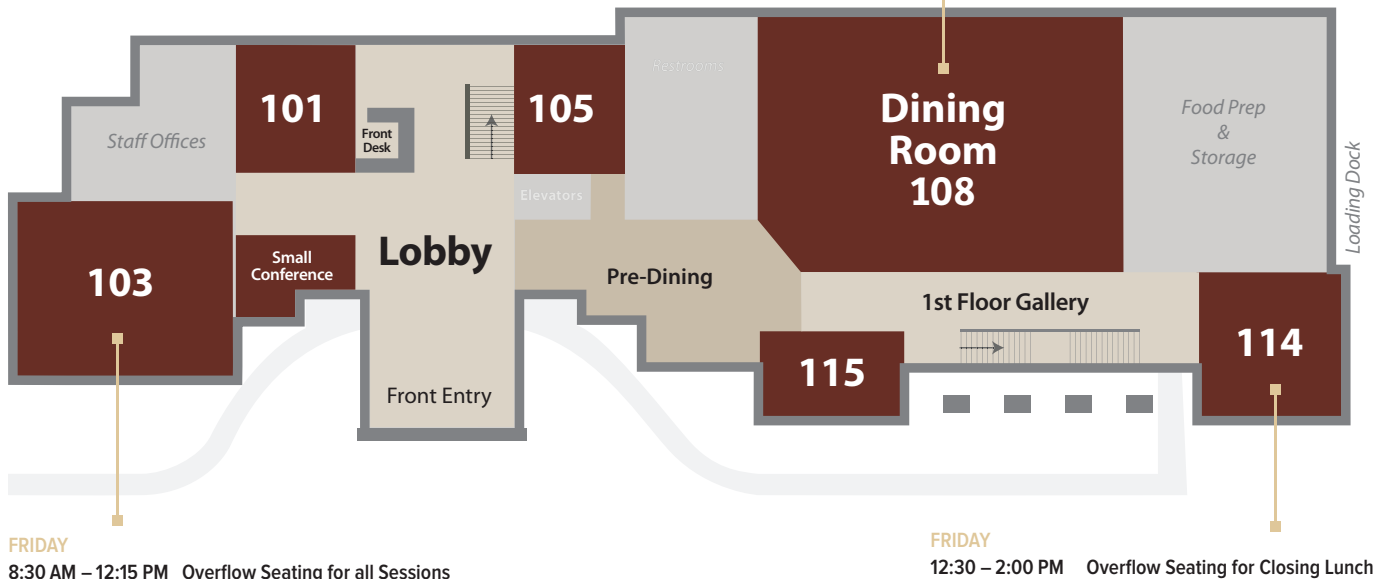
