# Robert D. Basham

Co-Founder, Outback Steakhouse, Inc. and Vice Chairman, OSI Restaurant Partners, LLC

After graduating from the University of Maryland, Basham started out in a family run restaurant business. In 1973, he went on to the management program of the Steak & Ale Restaurant Company and rose through the ranks to become V.P. of operations of the Bennigan's Concept and was instrumental in its successful nationwide expansion. In 1983, Basham formed Sunstate Restaurant Corporation to develop the Chili's Concept as a franchisee and joint venture partner. The company was merged with Chili's, Inc. in 1987 and Basham continued in his operations position until departing to found Outback Steakhouse with Chris Sullivan and Tim Gannon.

The first Outback was opened in Tampa, FL in 1988. Since then an additional 1,479 restaurants, located in 50 states and over 20 countries, have been opened. These include Carrabba's Italian Grill, Bonefish Grill, Fleming's, Roy's, LeeRoy's, Cheeseburger in Paradise, Blue Coral and Outback International. Basham is involved in the community serving as honorary chairman with the Junior Achievement, and board member for Metropolitan Ministries, the Boys and Girls Club Foundation, Berkeley Preparatory School, and the McDonald Training Center.
